

REQUIREMENTS FOR THE ISSUANCE OF A TEMPORARY ON- SALE LIQUOR LICENSE

1. Application shall be made, on forms provided by the City, to the Clerk/Administrator or designee a minimum of ten (10) days prior to the date of the City Council Regular Meeting at which the application is presented.
2. Request may not exceed four (4) consecutive days.
3. The city and state applications (state application only for temporary liquor license) shall be completed in their entirety.
4. A fee of \$50.00 shall accompany the application.
5. Certificate of Insurance stating that liquor liability will be in effect for the date(s) of the event(s) for amounts of no less than \$100,000.00 for injury to any one person, \$300,000.00 for injury to more than one person, and \$25,000.00 for property damage, naming the City of Isanti as an insured during the license period.
6. Completed Consent for Release of Information (with copy of applicant's driver's license).
7. The Chief of Police will conduct a background check, review the application and make a recommendation to the City Council.
8. The applicant will be responsible for enforcement of all policy conditions.
9. Law enforcement has the authority to inspect the area the liquor license is being applied for.
10. Law enforcement has the authority to remove the license when a violation exists.
11. Appropriate signs shall be placed to distinguish the area alcohol is to be served and all regulations.
12. Applicant shall meet all state fire codes.
13. The applicant shall meet with the Chief of Police to discuss issues of personnel, security, restroom facilities, proper identification of customers, emergency safety plan and expected number of attendees.
14. If the applicant is to have a special event where minors are present, the applicant must designate a specific area for the sale of the alcohol, a designated entry into the event area, serve the alcoholic beverage in a specific container and not allow consumption of alcohol outside that area.

Non-compliance with any of the attached conditions to the approval of a temporary liquor license for an event shall result in an immediate revocation of the license.

Subd. 10. **Temporary on-sale licenses.** (a) The governing body of a municipality may issue to (1) a club or charitable, religious, or other nonprofit organization in existence for at least three years, (2) a political committee registered under section 10A.14, or (3) a state university, a temporary license for the on-sale of intoxicating liquor in connection with a social event within the municipality sponsored by the licensee. The license may authorize the on-sale of intoxicating liquor for not more than four consecutive days, and may authorize on-sales on premises other than premises the licensee owns or permanently occupies. The license may provide that the licensee may contract for intoxicating liquor catering services with the holder of a full-year on-sale intoxicating liquor license issued by any municipality. The licenses are subject to the terms, including a license fee, imposed by the issuing municipality. Licenses issued under this subdivision are subject to all laws and ordinances governing the sale of intoxicating liquor except sections 340A.409 and 340A.504, subdivision 3, paragraph (d), and those laws and ordinances which by their nature are not applicable. Licenses under this subdivision are not valid unless first approved by the commissioner of public safety.

(b) A county under this section may issue a temporary license only to a premises located in the unincorporated or unorganized territory of the county.

(c) The governing body of a municipality may issue to a brewer who manufactures fewer than 3,500 barrels of malt liquor in a year a temporary license for the on-sale of intoxicating liquor in connection with a social event within the municipality sponsored by the brewer. The terms and conditions specified for temporary licenses under paragraph (a) shall apply to a license issued under this paragraph, except that the requirements of section 340A.409, subdivisions 1 to 3a, shall apply to the license.
