Public Works Updates

Streets:

Street painting of crosswalks, stop bars. School crossings, R/R crossings and parking lots was completed.

Storm:

Crews repaired a storm drain on East Dual Blvd in front of UPS. The repair required a new casting to be installed as well as some curbing.

Sewer:

- Annual maintenance of the Air release valves have been completed for the third time this year. This is part of our quarterly maintenance that we do on those.
- Sewer jetting has begun. This year we will be jetting to each lift station and cleaning the lift station itself. We jet primarily to prevent sewer backups in the system but also to inspect the infrastructure
- Generator Pads have been poured and the generator installs should be starting soon. The work is scheduled to be completed in October.

Water:

- Staff worked through some filter issues at the WTP. It was discovered that the filters were low on Potassium Permanganate which was causing our Manganese levels to rise in the system. The Permanganate is what the Iron and Manganese attaches too so that it can be filtered out. They were shocked with the Permanganate, allowed to sit. then backwashed before being put back in use.
- Staff cleaned out the backwash tank which is part of our annual maintenance. It is an opportunity that we take to discard all the Iron and Manganese that is removed during normal operation.
- Staff verified that all gate valves were open prior to hydrant flushing. During that time staff discovered that 8 gate valves were closed at different locations in town.
- Staff completed hydrant flushing and were able to complete a small list of hydrant repairs.

Parks:

- The Sledding Hill project has begun and should be completed in late September weather permitting.
- Crews have been fogging for Mosquitoes and will continue through September.
- Staff was able to pour concrete curbing at Rum River Meadows Park and that will be the last park that gets the curbing.
- The Compost Site is open and continues to be busy. The compost site Sunday hours will begin on October 25th with the compost site closing on November 8th for the season.
- The Community Garden is slowing down but the Sunflower Maze is in full bloom.
- The Farmers Market is open thru September 25.

Discussion on Legacy Pines 3rd Addition Letter of Credit

Background:

On August 18th the City entered into a Development Agreement with Everpine Holdings LLC for the development of Legacy Pines 3rd addition. This addition is broken up into three phases. Phase one is near completion. The developer is ready to start phase II (32 lots) and is requesting the following:

- 1. That I pay all necessary City fees for the 32 lots in Phase II and the required escrows in connection with Phase II. The City fees are Signal light fee, park dedication fee, trunk utility charge for a total of \$83,808.00 and an escrow of \$10,000 for engineering time/inspections.
- 2. That I post the minimum 10% of total construction costs amount that the City requires for the warranty period. Per the development agreement section 13." The Developer shall provide a financial guarantee to the City, in the form of a cash escrow, or irrevocable letter of credit in the amount equal to one hundred twenty five percent (125%) of the estimated amount of the required Developer Installed Improvements to be completed in the Phase(s) of the Development". This has been the policy for residential development and has been executed this way on all of the Legacy Pines phases. Allowing a reduced amount exposes the city to potential issues if the developer were not to install the improvements as planned. The 125% is to cover expenses if the city had to take over and install the improvements. The City attorney has advised against changing policy.
- 3. That at the end of the construction season, whatever amounts are yet needed to complete the unfinished work be posted with the City at this time

One option to consider is to break the LOC into two parts

- 1. Collect LOC for utility work only: \$177,140.57x125%= \$221,425.71
 - a. Remaining LOC needed to start surface work: \$401,604.16x125%=\$280,579.49

Request:

Staff is requesting direction on this item. If the Council would like to make an exception the development agreement will need to be amended. Council could add the amendment to the City Council agenda tonight and motion that the City Administrator and Mayor execute the amended agreement as motioned.

Executive Summary

For \$12,000, the City of Isanti can provide critical business coaching for up to 20 small businesses operating in Isanti. The goal is to drive optimal financial results during COVID and develop greater growth and resiliency post-pandemic. In partnership with the City of Isanti and the North 65 Chamber of Commerce, the Small Small Business (SSB) Community will provide four hours of private coaching to be completed by November 15, 2020. Participants will also receive lifetime access to the SSB website to connect with experts and access content specifically curated for small businesses.

Small Business Coaching Program

The retail cost (including administration) of the individual coaching and membership is \$800 per person, which is reduced to \$600 as part of the SSB COVID response.

The program includes:

- Four hours of individual coaching structured to maximize the impact for each owner
- Lifetime free Learn & Connect membership at smallsmallbusiness.com
- Post-program discounts on private coaching, group coaching, and mastermind groups

Background and Context
