#### D. Agenda Modifications

Remove Item A (Withdrawn by Petitioner): Request of RWL Properties, LLC, on behalf of Gymnastics Galaxy, to Amend Ordinance No. 445: Zoning Ordinance to include provisions for instructional classes, pre-school facilities, and daycare facilities as Accessory Uses to Commercial Recreational facilities.

Remove Item B (Withdrawn by Petitioner): Request of RWL Properties, LLC, on behalf of Gymnastics Galaxy for a Conditional Use Permit that would allow a gymnastics facility with accessory instructional classes and pre-school facilities on the property located at 101 Isanti Parkway NE.
