## 3. Business Climate Survey Preliminary Information

Economic Development Director Sullivan presented the Staff Memo. Sullivan indicated the he had received 12 surveys back at the time the preliminary data was put together. Since then he has received 3 more. 9% percent of the surveys have been returned at this point.

Chair Kuechle stated that with only a 9% return of surveys it would be very difficult to draw any conclusions/strategies with limited data. He wondered if it wouldn't have been better to send out some City Staff to conduct interviews.

Sullivan indicated that there was still quite a bit of time left to get more surveys as the deadline was November 1<sup>st</sup>. He stated that he was hoping to get 30-40% return. He also stated that if a lot of the survey were from industrial companies that there could possibly be some meaningful data that could be gleaned from that.

Sullivan asked the EDA if the way in which the preliminary data was presented was the form that the EDA would like the final report in.

The consensus of the EDA was that the format was good.

#### 4. Minnesota Manufacturers Week

Economic Development Director Sullivan presented the Staff Memo. Sullivan highlighted the fact that the Mayor issued a Minnesota Manufacturers Week proclamation for October 22-26. Economic Development Director Sullivan implemented a new program that included Certificates of Commendation signed by Governor Dayton to be presented by the City to each manufacturer in the City. The City has 19 manufacturing businesses.
