5. Consider Advertisement in Business Climate Magazine / Online

Economic Development Director Sullivan presented the staff memo and outline the advertising options. He indicated that the publication would be in print and online and that DEED was going to use it in all of its trade shows and would be direct mailed to site selectors. He stated that DEED has a three year contract with the publication and that he thought it would be a good idea to partner with the State of Minnesota. This is not a budgeting item for 2015 but there are funds available in the EDA marketing 495 fund. He suggested that we use the same map we currently use, or something very close, in the Invest in Isanti brochure.

President Wimmer stated that he had asked Economic Development Director Sullivan to work on a more robust marketing plan for 2016 and that he thought that this was a start to that program. He wants to keep project coming into the development pipeline.

Sullivan agreed that keeping deal flow going was important but that landing all prospects was not realistic.

Discussion ensued and consensus was that this was a great opportunity and that the EDA supports it.

Motion by Lundeen to recommend to City Council to purchase advertising from Journal Communication for the Business Climate Magazine and to select the ½ horizontal with leaderboard at a cost not to exceed \$3,160.00, second by Johnson, motion carried unanimously.
