He indicated that the City Council had authorized Bolton and Menk to get a formal cost estimate to utilize the dirt on hand to level lots within the City Industrial Park. In addition to the leveling and grading, the quote would include the cost to remove large trees from the site which is also a TIF eligible expense.

4. Resolution Authorizing Revolving Loan Fund Agreement with K & D Investment, LLC

Economic Development Director Sullivan presented the Staff Memo. MCR will be purchasing the property located at 442 First Avenue NW. IT will be used for a precision machine shop and will bring 9 employees immediately to Isanti. The City has committed to \$22,500 from the City Revolving Loan Fund. The business is required to create at least 2 new jobs over the next two years as part of the Loan Agreement.

Sullivan stated that this project moved very quickly once a decision to purchase the building was made by MCR. The change in the Revolving Loan Policy allowed the process to move quickly and get the business in the building as soon as possible.

No action was requested and not action was taken by the EDA as this was an informational item.

5. Invest in Isanti Marketing Brochure Draft

Economic Development Director presented the Staff Memo and outlined the changes that has been made to the brochure. The EDA asked that further changes be made to the brochure. The changes included:
