## **Peddler, Solicitor or Transient Merchant License Application**

**Application for a license must be made at least 10 working days before the regulated activity is proposed to begin.**

Peddler includes a person who goes from place to place exhibiting merchandise for sale, making sales, and delivering articles to purchasers.

Solicitor includes a person who goes from place to place soliciting orders for the sale of merchandise or personal services for future delivery or future performance, whether or not the person has a sample of the merchandise or is collecting advance payments for the orders. The word also includes activity that has as its ultimate purpose the obtaining of orders even though it may not initially purport to do so. The term “solicitor” shall have the same meaning as the term “canvasser.”

Transient Merchant includes a person who temporarily sets up business out of a vehicle, trailer, tent or other portable shelter or empty storefront in a commercial district where retail sales are a permitted or conditional use for the purpose of exposing or displaying for sale, selling or attempting to sell and delivering good, wares, products, merchandise or other personal property and who does not remain or intend to remain in any location for more than 14 consecutive days.

The undersigned hereby makes application for a peddler, solicitor or transient merchant license under the provisions of the City of Isanti Code Chapter 245 which can be found at [www.cityofisanti.us](http://www.cityofisanti.us) and submits the following facts in support thereof.

No fee will be collected for solicitor and transient merchant but applicant must indicate length of license to which is being applied for.

The license you will be given must be carried with you at all times and any individual who will be conducting the regulated activity on behalf of organization when peddling/ soliciting in Isanti.

You are being asked to answer questions and provide information pursuant to the peddler, solicitor and transient merchant licensing and application process that is required by the City of Isanti, Minnesota city code. The purpose and intended use of the requested data is to verify that each applicant meets the requirements for state statutes and city code provisions and, if the license or permit is approved, to verify that all required data remains current.

The following data collected, created, or maintained is classified under the Minnesota Government Data Practices Act as public data once a license has been approved (Minn. Stat. § 13.41, subd. 5):

1. Data submitted by applicants (other than names and designated addresses)
2. Orders for hearing, findings of fact, conclusions of law, and specification of any final disciplinary action
3. Entire record concerning any disciplinary proceeding
4. License numbers
5. License status

The following data collected, created, or maintained is classified under the Act as private data (Minn. Stat. § 13.41, subd. 2):

1. The identity of complainants who have made reports concerning licenses or applicants which appear in inactive complaint data unless the complainant consents to disclosure
2. The nature or content of unsubstantiated complaints when the information is not maintained in anticipation of legal action
3. Inactive investigative data relating to violations of statutes or rules
4. Record of disciplinary proceedings, except as limited by the provisions above

The following data collected, created, or maintained is classified under the Act as confidential data ((Minn. Stat. § 13.41, subd. 4) :

1. Active investigative data relating to complaints against any license.

Under law, private data may be shared with licensing and inspection employees, approval authorities, insurance providers, law enforcement employees, contracted inspection officials, city officials who have a bona fide need for it, or as required by court order. The City of Isanti may make any data classified as private or confidential accessible to an appropriate person or agency if the licensing agency determines that failure to make the data accessible is likely to create a clear and present danger to public health or safety.

We ask that you complete or provide all data requested on the application form(s) unless we have noted that it is not required. Refusal to supply required information may mean that your application cannot be processed.
