# **Memo for Council Action**

**Subject**: Closing Funds 441 and 933 to Fund 425

## **Background:**

Construction Fund 441 was created in 2017 to track expenses associated with the Palomino Road Street and Utility Improvements. Fund 933 was subsequently created to track the receipt of special assessment revenues for the project. All current and future street projects are and will be tracked in Street Construction Fund 425. This would include expenses and special assessments. This method of "reusing" the same Fund year after year to track like projects is recommended by our external audit firm.

### **Recommendation:**

Staff is recommending, in consultation with our audit firm, that Funds 441 and 933 be closed to Fund 425. This action, if adopted would be effective for year end 2021 and be represented on the audited financials, to be presented to Council on April 19<sup>th</sup> 2022.

## **RESOLUTION 2022-XXX**

### **AUTHORIZING THE CLOSING OF FUNDS 441 AND 933**

**WHEREAS**, the City Council of Isanti finds that it is important to review financing to eliminate deficits in certain funds and close funds with no recent activity or for projects that are materially complete; and

**WHEREAS**, the City Council of Isanti finds that it is in the best interest of the community to close Construction Fund 441 and Debt Service Fund 933 to Fund 425 – Street Construction Fund retroactively effective to 12-31-2021; and

**WHEREAS**, Funds 441 and 933 had been created to track expenses and special assessments related to the 2017 Palomino Road Project;

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the City Council of Isanti, Minnesota, to:

1. Close Funds 441 and 933 to Fund 425 – Street Construction Fund, effective December 31<sup>st</sup> 2021.
