RESOLUTION 2020-XXX

ALLOWING IN-PERSON MEETINGS OF CITY COUNCIL AND OTHER CITY MEETINGS TO RESUME WHILE OBSERVING 6' DISTANCING

WHEREAS, The City of Isanti passed Resolution 2020-076 Consenting to Mayors Declaration of Local Emergency; Extending the Period of the Local Emergency; and Authorizing Certain Actions and under authority of Minnesota Statute, Section 13D.021 to hold meetings virtually as they were impractical to do so; and,

WHEREAS, by Emergency Executive Order 20-01, Governor Tim Walz had declared a Peacetime State of Emergency to authorize any and all necessary resource to be used in support of the COVID-19 response, as of March 13, 2020, which still continues; and,

WHEREAS, modifications to Governor Tim Walz Executive Orders has lifted some of the Orders governing meetings; and,

WHEREAS, the City Council agrees that in-person meetings of the City Council, Planning Commission, and other Commissions and Boards of the City of Isanti are practical to meet in-person while maintaining the social distancing requirement of 6' and acknowledges that persons wishing to attend these meetings will be able to do so on a first come basis;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Isanti City Council has determined that in-person meetings may resume for all City meetings with seating spaced 6' apart and the public is allowed to attend on a first come basis.

This Resolution is hereby approved by the Isanti City Council this 2nd day of June 2020.
