This issue of the Isantian will include a review of several of our City departments and the associated staff. It is important for our taxpayers to know the services we provide and the individuals that make it possible. Our Winter Edition will have the remaining department information.

We had some great successes this past summer with the expansion of existing businesses such as Granger and Lexington Textiles. New businesses have also appeared such as SnoBear USA, Bow Daddy Archery and Crossfit Beyond Sport. Stay tuned as more announcements will be made regarding new businesses coming to Isanti this fall and winter. Economic development is a long process from start to finish. Our recent success shows we have benefitted from investments in marketing our community. We are dedicated to bringing in new businesses by making important strategic investments in marketing and will continue to assist existing businesses through information shared through business retention visits and communications.

New housing starts continue to remain strong with 27 new home construction permits to date. Isanti does not subsidize residential growth as other communities have. We believe development must pay for itself and not burden existing taxpayers. With that being said, we are seeing strong numbers of residential housing starts.

We continued our investment in providing a safe community by promoting Officer Noreen to our new Police Investigator position and hiring Chelsea Doherty to fill the open patrol officer position. Please welcome them both to their new positions and to our community. We have a professional dedicated department that does an incredibly tough job that is often overlooked and undervalued.

The City of Isanti Compost site will reopen in the spring of 2016 in full compliance with all state regulations. The site will be secured with an attendant to ensure that only allowed materials are dropped off. The site was closed due to the irresponsible use by some that turned our compost site into a contaminated facility. The current compost material will be disposed of properly and the site will be prepared to accept new compost materials in the spring of 2016. The hours of operation will be determined this winter and information provided on the City's website.

The City Council approved our preliminary budget and levy for 2016. The major changes to the budget include no longer relying on the cash reserves to help pay for operational costs. My original plan created in 2009 anticipated using these reserves through 2017, but we are able to end a year early. We will also start replenishing these reserves by putting \$53,000 back in these funds. Another key item explained to Council is the anticipated increase in city assessed value of 13.9% by the County Assessor. This means the City property values as a whole will increase by that percentage. As we experienced last year with a similar high increase in values, this can affect individual properties differently. A house may see a 20% or more increase while another may actually decrease. This is based on a state mandated valuation process. If the county does not comply the state can force even higher valuations, which occurred in Isanti County a decade ago. The other issue with this process we should be aware of is the timing of different requirements by the state. As a City we must get our preliminary levy decided before the county has to provide firm valuation numbers. This means we are making our best educated determination based on their preliminary numbers. If those change, it can have a negative effect on our levy and property taxes.

I want to invite everyone to join us at our 1st Annual Two Cities, One Community event. I created this title and event to encourage the idea that although Isanti and Cambridge are distinct cities with our own identity, we are members of an incredible overall Community. The details of this event are in this issue. Each year we will build on this event and make it a foundation of our events calendar.

# Isanti's Green Initiative

Recently, the City of Isanti approved a resolution to become one of Minnesota's GreenStep Cities. This program is designed to help our community achieve environmental sustainability goals through the implementation of 28 best practices. These best practices are organized into the categories of: buildings and lighting, land use, transportation, environmental management, and economic and community development.

Each best practice can be implemented by completing one or more specific actions from a list of four to eight actions. These actions encourage innovation, focusing on cost savings and energy use reduction.

Tailored to all Minnesota cities, GreenStep Cities grew out of a report to the 2009 Legislature and has been developed by the MN Pollution Control Agency, MN Office of Energy Security, the League of MN Cities, the Clean Energy Resource Teams, the Great Plains Institute, the Izaak Walton League-MN and the Urban Land Institute-MN. ### The City of Isanti Welcomes SnoBear USA





The City of Isanti and SnoBear USA are wrapping up the final details that will relocate SnoBear USA's world headquarters and manufacturing facility, from Fargo, ND to Isanti,

Minnesota. SnoBear USA LLP manufactures snow track vehicles for recreational, commercial and governmental use. The project will involve the purchasing of an existing 42,000 square foot building in Isanti as well as the construction of a new 12,000 square foot building next year.

This project is estimated to bring 25-40 great paying new jobs to the City of Isanti over the next two years. The City Development Project Team worked hard with the management of SnoBear and the State of Minnesota Department of Employment and Economic Development (DEED) to put together an assistance package that makes this move possible. During a day long visit on August 26, 2015, in the City of Isanti, Congressman Nolan took this opportunity to meet with the owners and toured an actual SnoBear vehicle. It's never too early to start thinking about ice fishing in Minnesota, especially when you're fishing from one of these impressive vehicles!

City of Isanti Increases Marketing to Wider Audience

The City of Isanti will be involved in the Department of Employment and Economic Development Site Familiarization (FAM) tour in 2015. The State of Minnesota has secured national site selectors to tour specific economic development regions in the State of Minnesota. The City of Isanti is part of a five County Region consisting of Isanti, Kanabec, Pine, Mille Lacs and Chisago Counties. This group of counties, GPS 45:93, local cities, and electrical cooperatives, have pooled resources to pay for a site selector to tour this region and provide a presentation. The site selector will be in the area from September 14-15 and will be meeting with local businesses and Economic Development Staff. This tour gives Isanti the ability to showcase its Minnesota Shovel Ready Certified industrial lots and the great business community that has chosen Isanti as home.

The City has also partnered specifically with Connexus Energy to advertise in print and online with Journal Communications in the Department of Employment and Economic Development's new marketing magazine called "Minnesota: Thriving in the North". This publication will be available and distributed to site selectors and businesses at national events attended by the state Economic Development Staff and Governor lead trade Missions. The City will be given magazines for its use to help with marketing done locally as well. As shown with SnoBear USA, Isanti has the ability to draw from outside of the State of Minnesota with certain projects.

The Building Department is overseen by the Community Development Director. The Department is currently staffed by the Building Official Rick Sames and part-time Building Inspector Nick Henly. The Department is responsible for:

- Enforcing State Building Codes as adopted by the City; regarding building, plumbing, and mechanical
- Process building permits; perform plan reviews, collects fees.
- Reviews permits, designs, and inspects on-site sewage treatment systems.
- Assists with nuisance and zoning code compliance, including monitoring of foreclosed properties.
  - Administers Rental Housing License Program.
  - Maintenance Coordinator for City owned build-

ings/facilities.

Both of the staff members within the Building Department have acquired knowledge and skills through past work experience and education; which enables them to perform the duties associated with their positions. Rick Sames, Building Official, is a licensed Building Official with the State of Minnesota for Building, Plumbing, Mechanical, Accessibility, Fire and Energy Codes; is certified with the Minnesota Pollution Control Agency for septic design and inspection, and attends yearly continuing education courses to maintain his credentials. He is a member of the International Code Council as well as a member of the East Central Building Officials Organization. Mr. Sames has taken college courses in architectural drafting, fire suppression, plumbing and inspections, mechanical systems and inspections, building inspections, and plan review. He has 10 years of experience as a carpenter, 18 years as a licensed contractor, 3 years as a building inspector, and 12 years as a building official. Mr. Sames is planning to retire at the end of 2015.

Nick Henly, part-time Building Inspector, is a state certified Building Official – Limited, and an ICC nationally certified Residential Building Inspector. Mr. Henly obtained his Building Inspection Technology Certificate through North Hennepin Community college. Nick is also a member of the International Code Council (10K Lakes Chapter) professional organization.

# **Building Department News - Fall 2015**

#### WELCOME TO FALL ISANTIANS!

I am very happy to report that no fires have occurred since last fall's Isantian update. To continue this fortunate safety streak, I want to remind you all to test your smoke detectors and re-visit your emergency escape routes and plans with your family. And please be aware that smoke detectors do not last forever! Battery operated smoke and CO detectors have an expiration date - be sure to check your brand's expiration date and replace if needed. The expiration can often be found on the back of the detector, and the average life is 7-10 years.

Also, cooler fall evenings tend to spur more bonfires - so we'd like to remind all of you flame fans about the State Fire Marshall's requirements for fire pits. The fire ring may be no more than 3' in diameter, the flames can be no higher than 3', and any combustible structure must be at least 25' away.

As always, feel free to call the building department at any time with questions regarding building, permits, inspections, etc. The department is in place to help the citizens of Isanti build, alter, repair, and add on to structures and property in a safe and consistent manner. Thank you,

### **Winter Parking** Restrictions

Parking of vehicles is not allowed on city streets between the hours of 1:00 a.m. and 8:00 a.m. from November 1st through March 31st of every year. Parking is permitted on streets between the hours of 6:00 a.m. and 8:00 a.m. provided that snow removal has been completed or there is no snow. Parking is not permitted in the City's downtown municipal parking lot (located south of Main Street W and west of the BNSF railroad tracks) between the hours of 1:00 a.m. and 5:00 a.m. Your cooperation will help make the snow removal process more efficient and effective.

### Yard Waste in **City Streets**

The City has experienced some issues with grass clipping, leaves, and other types of yard waste being deposited from residential lots into City streets and storm drains. These items obstruct the flow of rain water that runs through the public street drains and gutters, causing flooding on residential lots that surround these areas. Isanti City Code section 216-2 identifies the placement of trash, grass, other yard waste or other materials as a public nuisance affecting health. Please avoid using the public street for the disposal of these items. Failure to do so may result in a citation for violation of Isanti City Code.

### Water Shutoffs

Due to the upcoming change in seasons, and oncoming cold weather, if your home is going to be vacant for any reason; please call City Hall to have the water shut off to prevent freezing pipes and other water damage.

City Code section 325-9 (E) authorizes the City to disconnect services due to electric and/or gas utility services being shut off between October 15 and April 15; if the City determines in good faith that the premises has been vacated by the former account holder and no transfer of the account has been made.

 Provides day-to-day administration over all City Departments. Assists department heads with projects, policy development and as needed assists in their absence with department administration.

• Develops draft procedures, policies, and programs to improve the health, safety, and welfare of the City, to respond to organizational needs and governmental mandates.

• Works with department heads and staff to administer community development programs, assistance with planning and development matters as well as financial matters and budget preparation.

• Coordinates consultant services and assists with projects, as necessary.

• Executes governmental functions as City Clerk, as required by State



### A message from Isanti Fire

Happy late summer Isanti!

An interesting and scary statistic: According to the National Fire Protection Agency (NFPA) nearly 2/3 of residential fire caused fatalities occurred in structures that didn't have any smoke alarms, or had smoke alarms that were inoperable. That would equate to 1,804 deaths in U.S. homes in 2013 that didn't have a chance to hear these \$10 devices alert them to get out. This October's fire prevention message is "Hear the BEEP where you SLEEP". Let's keep Isanti out of these ugly statistics. Do you have a working (and hopefully interconnected) smoke alarm in your and your families sleeping areas? If you have any questions on this please call the fire station at (763) 444-8019.

Please note the graph for a breakdown of what services Isanti Fire District has responded to in the City of Isanti this year to date. Throughout these 180 calls, the firefighters have averaged a response time of 3.2

Correction! My last entry to the Isantian was on data and how the department tracks different pieces of it to help us preplan and judge our services. My report stated our per capita dollar amount charged to City residents for our service was \$24.98. This should have read \$33.39.

This per capita amount was reached by taking the quarterly contribution to the Isanti Fire District by the City of Isanti of \$45,064.01 times 4 (\$180,256.04 annually) and dividing it by 5,397 (2013 census). My apologies for this error on my part.

The Isanti Police Department will again offer ATV Youth Safety Classes this year. We certified about 55 youth at our August 15th class and will be offering one more class beginning Saturday, October 10, 2015. The class and riding session will be held at the Isanti Community Center. There is a training CD that each student will need for the class and that can be obtained by coming to the Police Department or by contacting the MnDNR at 1-888-646-6367, 651-296-6157, or 800-366-8917. You can request a CD through email by writing to info.dnr.@state. mn.us. Registrants must be age 11 or older to take the class. If you are 11, you cannot receive your certificate until your 12th birthday. There is a \$10.00 fee for the class.

Any person operating an ATV in Minnesota born after July 1, 1987 must possess an ATV safety certificate in order to operate an ATV on public lands, trails or waterways (obviously when frozen). If you have any questions regarding ATV operating regulations you can stop at the office to pick up a DNR rules and regulations booklet. Watch the Winter Isantian for the snowmobile safety class dates and times.

Within the city, Class 1 ATV's and golf carts may be driven on municipal streets under certain restrictions. A city ATV permit and application can be obtained at the Police Department. The permit sticker costs \$25.00 per year. Have a great and safe remaining summer!

**National Preparedness** Month—September is National Preparedness Month, sponsored by the US Department of Homeland Security. One goal of Homeland Security is to educate the public about how to prepare for emergencies, including natural disasters, mass casualties, biological and chemical threats, radiation emergencies, and terrorist attacks. Fire Prevention Week-Fire prevention week is October 4-10. No matter what type of device you use to heat your home, verify that your heating systems are in good working order before you experience the first cold snap of the season. When you turn your clocks back for Daylight Saving Time, it's also a great time to check the batteries in your smoke alarms and carbon monoxide detectors. Verify and replace any home fire extinguishers that have expired.

Fall Driving - Cold fall mornings often lead to fog. One common mistake is to put on high beams instead of staying with low beams. High beams only make visibility worse because they bounce off fog and create glare. Deer are out and about more during the fall season because of mating and migrating, so keep an eye out for them. If you live in a deer-heavy area, watch for darting deer especially when driving at night.


