4th Tuesday of the month at 7:00 p.m. We have quite the year ahead of us. I want to first welcome our newest member to the Isanti City Council, Ross Lorinser. He was appointed to fill the remaining two years of former Council Member Duff's term.

The City Council held its annual Goal Setting session and established the following goals:

- Complete the Long Term Financial Plan (LTFP)
- Increase Commercial Tax Base
- Disaster Plan
- New Personnel Policy
- City Multi-Modal Transportation Plan

We have a few items to complete on the LTFP and creating a reader friendly summary to communicate to our Citizens and Taxpayers. Increasing our commercial tax base is a key to our future development as a City. The Disaster Plan is a tool that helps us operate during crisis situations of all types such as a natural disaster but also if we lose key personnel. A new personnel policy is needed to deal with the many changes Isanti has experienced in the past few years. Having the appropriate policies in place saves us time and money in the long run. The City multi-model transportation plan is intended to make sure all of our transportation issues are addressed. This includes a road frontage system on the west side of Highway 65, park & rides, integrated transit system linking to the metro, railroad and pedestrian uses.

The other major area I wanted to touch upon is the City's budget situation. We should all be aware of the state deficit crisis and how it has trickled its way down to Isanti. The state certified Local Government Aid (LGA) payments have been cut for 2008 and the foreseeable future. Isanti has already dealt with a \$112,000 cut at the end of 2008 and the Governor's budget cuts a further \$140,075 in 2009 and \$292,591 for 2010. This lost revenue coupled with over \$274,620.44 in delinquent taxes and \$220,069.55 in unpaid special assessments makes budgeting difficult. The Governor's budget balanced a \$4.8 billion deficit which is anticipated to grow to over \$7 billion so these numbers may get worse.

When a city is told the certified LGA amount, they put that number into their budget. In past years Isanti would have budgeted the certified amount into the current year and the state would have paid the full amount to the City by the end of that year. With the state failing to live up to its obligation, twice in the past 5 years, it would be a dereliction of duty if the Council continued to trust the state's ability to fulfill its responsibility.

In response to this situation I have proposed and the Council enacted a fundamental shift in how we use LGA. I call it the LGA Flip for lack of a better term. We are flipping the LGA ahead a year. To do this we have cut spending, increased the liquor store transfer and borrowed from our ample fund reserves. The loan will be paid back on a 5 year no interest term. This allows us to use whatever amount the state finally decides to pay Isanti in 2009 for the 2010 budget. This will be cash in hand and a true number to budget with. This process will forever eliminate the devastation caused by any future unalloment. The LGA Flip gives Isanti greater control of our budgeting process.

We face difficult times but as proven by our recently attained A+ credit rating, our disciplined fiscal approach is working. We have already saved roughly \$130,000 by leveraging our improved credit rating. Our service level continues to rise even in these challenging times. I look forward to the grand openings of our nearly completed economic development projects, Ever Cat Fuels and Isanti Retail Meats, which will provide dozens of new good paying jobs.

There is so much more to discuss but my space is limited. I hope to continue hearing from our Citizens and Taxpayers through email, phone calls and visits during my office hours.

The City Council has made economic development a priority again in 2009. The Council's goal to strengthen the "Commercial Tax Base"; encompasses the goals of prior years, which is to bring more commercial and industrial businesses to Isanti. As the economic forecast in our country has been dismal, Isanti still has may businesses that we are working with to locate within our City. Already this year, two new businesses have opened in our City – Charisma and Big Dog Pizza.

In 2008, the City witnessed eleven businesses locating and relocating. The Downtown became a topic of conversation in our region with the mural on the Family Pathways wall, the banners on the street lights, flowers and benches. The City was also the recipient of the Economic Development Association of Minnesota's Business Recruitment award – only one such award is given a year. Business retention visits continued and we learned from our local businesses on matters that are important to them. The Mayor also held this first annual Business Luncheon; which recognized our local businesses and the contributions they give to our community, to include tax base, jobs, opportunities, volunteering and so much more.

In 2008, the City created a tax abatement policy and a Revolving Loan Fund. Both of these items are to assist in business development within Isanti and enable the City to remain competitive, as many other cities have similar programs to lure businesses. Staff also worked on the Rental ordinance and the foreclosure project, both of which have been successful.

Recreationally, the City welcomed the BMX Land O'Lakes Nationals and the Owls Hockey team. Both have brought people to our community and additional business.

For 2009, the City of Isanti has some things to look forward to, which include the following: First, the City has applied for funds for a second downtown mural. We will know if we received the funds in late February. If granted, the funds would bring a mural to the east side of the American Family Insurance building in the southwest corner of First Avenue SW and Main Street W.

Second, the long awaited opening of Isanti Retail Meats in our downtown and Ever Cat Fuels in the industrial park will also take place in 2009. Both businesses are celebrated additions to the community. Each business will create additional employment opportunities, which are needed.

We urge you to let Community Development Director Vita (763-444-5512 or <u>cvita@cityofisanti.</u> <u>us</u>) know of any business or industry that may have interest in our community or that may be considering relocating from their current location. The Isanti Team will work to assist the business to be a part of our business community.

Construction

MNDOT has stated that the intersection project at TH 65 and CSAH 5 is still planned for this year. City Staff does not have a date certain when construction may begin, but we have been informed that the spring weather will make a difference. The details are the same as last year with new signals, concrete medians and additional turn lanes. The upgrades to the intersection will make it safer for all of us. Subdivision Ordinance

As part of the adoption of the 2008 Comprehensive Plan, one of the implementation tools of the plan was for the City's subdivision regulations to be reviewed against the recommendations of the Comprehensive Plan, and revised and modified where necessary. Staff has been working on those revisions to ensure that proper physical development and adequate public facilities within the City and its growth areas will occur in the future.

We have many unfinished permits in my files. If you have not called for a final inspection on your projects I encourage you to do so ASAP. In many cases the permit has expired but we **MAY** be able to work something out without requiring additional permit fees.

We have finished the initial canvassing of the city trying to locate all rental residential housing. If you own rental property or are living at rental property and have not been contacted, you probably were inadvertently missed. The City of Isanti does require rental housing to be licensed and so if you have been missed, please contact my office immediately.

Small Business Development Center Serves the Isanti Community

Whether you are thinking of starting a business or growing your existing business, the Minnesota Small Business Development Center (SBDC) satellite office at Anoka-Ramsey Community College's Cambridge Campus, is here to help you.

Counseling is provided by professional consultants and qualified volunteers who have extensive, practical experience in areas such as marketing, finance and accounting, operations and business planning. Most consultants have been business owners themselves and have advanced college degrees.

Restrictive Watering Ban in Force

City Code Chapter 325 shall be enforced as follows: During the period from May 1 through September 1 annually, all property with address that end with an odd number may be sprinkled on odd numbered days, and property with address that end with an even number may be sprinkled on even numbered days.

Total ban of sprinkling from 12:00 Noon to 6:00 p.m. only odd/even sprinkling allowed. This water restriction will be enforced. Violators shall be fined.

Properties with new lawns of less than six weeks old may be exempt from the odd/even sprinkling restriction. Please call City Hall to request the exemption.

City Flag

The Park and Recreation Board have moved on to the next phase in the creation of the City Flag. The Park Board has worked to create a final design, which takes into consideration each of the components identified within the winning flag drawings. The final design will be converted into an electronic document that will be sent to various flag companies for final modification and production. The Park and Recreation Board hopes to have the project completed this spring, so the flag can be flown over City Hall.

Student Representative

At the first meeting of 2009, the Park and Recreation Board discussed the creation of a volunteer position for a student representative to sit on the Park Board. The Board members felt that this position would give one area student an opportunity to get involved in the governmental decision-making process. In addition, a student's prospective on the City's park related programs and opportunities would be a great asset to the community and would enable the City to be responsive to the needs and requests of the community's youth. While the position would need to be reviewed and approved by the City Council, the Park Board is excited to be considering this type of opportunity for an area youth. Further details and information will be provided at a later date.

Bike/Walk Trail linking Isanti and Cambridge

After several years of planning and fundraising, the Bike/Walk Trail linking Isanti and Cambridge is on its way to becoming a reality. Funds have been allocated by the federal government as well as by the State of Minnesota, the City of Isanti, City of Cambridge, and Isanti Township to help with the design and construction of this regional trail project. Representatives from each of the various entities have been meeting to discuss the location, design, and timeframe for the development of the trail. This trail will serve as a major transportation linkage between the City of Isanti and the City of Cambridge. The project is in the preliminary design phases; however, both communities hope that the trail will be constructed and open to the public by the end of 2009.

City of Isanti Awarded Neighborhood Stabilization Funds

On February 26, 2009 the City of Isanti received notification that the City was selected to receive \$552,855 in Neighborhood Stabilization Program (NSP) Funds. The City will use the funds to increase home ownership in targeted neighborhoods where there is a high incidence of foreclosures. The funds do have requirements such as the funds are for homeownership; the property to be acquired must be foreclosed and vacant; and the homeowner must meet income guidelines. 2009 Amended Budget

Isanti City Council approved the 2009 budget at its December 16, 2008 meeting. On January 6, 2009 City Council approved Resolution 2009-003 which authorized amendments to the 2009 budget. Resolution 2009-027 was approved on February 3, 2009 authorizing a second round of amendments to the 2009 budget.

The original budget for 2009 included expenditures of \$3,407,479 which was an increase of 3.3% from 2008. The amended budgets includes expenditures of \$3,341,456 which is an increase of 1.3% from 2008. Both amendments were considered necessary due to anticipated reductions in Local Government Aid.

A copy of the 2009 amended budget is available on the City's website.

Codification of City Ordinances

On February 17, 2009 the Isanti City Council approved the new City Code. The City Code consists of the codification of most City Ordinances and places them within one book; therefore making it much easier to locate a specific code. The Code is divided into parts. Part I, Administrative Legislation, contains all City legislation of an administrative nature, namely, that dealing with the administration of government, that establishing or regulation municipal departments and that affecting officers and employees of the municipal government and its departments, Part II, General Legislation, contains all other city legislation of a regulatory nature. Items of legislation in this part generally impose penalties for violations of their provisions, whereas those in Part I do not.

The Code does not include the Zoning Oridnance, Subdivision Ordinance, Storm Water Management Ordinance, and other related zoning ordinances; they still remain in effect and can be found on the City's website. All new Administrative and General Legislation that is adopted within the current year will be placed on the City's website. At the end of the year the City Code will be amended to include all newly adopted legislation. Pedestrian Bridge - One Step Closer to Becoming a Reality

On February 25th, 2009, the House of Representatives approved the Omnibus Appropriations Act. Within that Act, the City of Isanti will receive \$950,000 towards the construction of the Pedestrian Bridge that has been proposed to span over Trunk Highway 65, providing a safe crossing for pedestrians and bicyclists. As of the printing of this publication, President Obama has not yet signed the bill into law.



Fee Schedule

Isanti City Council approved City Code Chapter 160 and Resolution 2009-009 authorizing the changes to the Fee Table and Fee Schedule.

City of Isanti Achieves A+ Rating

On November 25, 2008 the City of Isanti was notified by Standard & Poor's that a bond rating of A+ has been issued. This bond rating was used to issue \$1,275,000, General Obligation Improvement Bonds, Series 2008A and \$570,000 Obligation Water General Revenue Bonds, Series 2008B. These bonds were issued to cover the costs from the 2008 street and utility project, 2007 SE Quadrant Highway 65 project, and East Highway 65 utilities. The increase bond rating reduced the interest to be paid over the life of the bonds by \$55,375.

On January 23, 2009 Standard & Poor's again notified the City of Isanti of an A+ bond rating. The City utilized the bond rating to issue \$1,120,000, General Obligation Crossover Refunding Bonds, Series 2009A. These bonds were issued to pay off the General Obligation Sewer Revenue Bonds, Series 1999A and General Obligation Improvement Bonds, Series 2001A. Due to the bond rating and available interest rates the City received a net present value benefit of \$71,679.07.

Standard & Poor's provided an A+ bond rating based on the following rationale:

 Access to Twin Cities economic base;

- Good income levels, as measured by median household income;

 Strong market value levels that continue to grow; and

 Very strong financial operations, as evidenced by a high general fund balance reserve and positive operation results.

Attention Dog Owners

Please be reminded that dog licenses are due on March 31, 2009. All dog owners must license their dogs annually. License fees are \$10 per year for fixed dogs and \$15 per year for nonfixed dogs. A late fee of \$5 will be charged if licensed after March 31, 2009. City Code states that any property owner who has more than two dogs must obtain a kennel permit. Sign Regulations

As a reminder to current business owners and any other individual looking to construct or place a sign upon their property, the City of Isanti has adopted regulations for signage. The ordinance regulates the location, size, placement, and various features of signs to enable the public to locate goods, services, and facilities without difficulty or confusion; to prevent the wasteful use of resources in competition among businesses for attention; to prevent hazards to life and property; and to ensure an aesthetic value of the City.

Property owners looking to construct signs are required to obtain a sign permit from the City prior to construction and/or location of a sign. All signs are reviewed by City Staff to ensure compliance with the sign ordinance regulations. Signs constructed without a permit or signs found to be in violation of ordinance requirements and standards may result in revocation of the sign permit for that particular business and/or issuance of a citation due to noncompliance with City Ordinances. Please contact the Planning Department for all questions and concerns regarding sign regulations.



New Zoning Ordinance

On October 21, 2008, the Isanti City Council approved a new zoning ordinance. The new ordinance will help the community to grow and develop into the future. Overview of City Nuisance and Parking Code

City Code Chapter 216, Nuisances, provides for maintaining a safe, healthy, and aesthetically pleasing environment to the citizens of Isanti. § 216-2 covers nuisances affecting health such as outside accumulation of rubbish, salvage materials, junk, unlicensed vehicles and other items causing a depressing influence on property values in the area.

City Code Chapter 227 regulates the outdoor parking and/or storage of vehicles, boats, trailers, RVs and other items. The City Code does include a listing of proper requirements for storage of such units (Exhibit A). They need to be parked on impervious or improved surfaces. There are also time limits for parking such units in the front yard. Units stored on side yard and/or back yard must be 80% screened from view of neighboring property or a public street.

Weed and Grass Nuisances

Summer is approaching and with that comes the season of lawn care. The City of Isanti would like to bring to your attention City Code – Chapter (§) 216 and the fees associated with this.

§ 216.2H. states: All noxious weeds and other rank growths of vegetation upon public or private property.

§ 216-5 Abatement: In accordance with the notification requirements of Section 6 of the City Code, and after seven (7) calendar days notice by the City, the Public Works Director shall implement the mowing and removal of noxious weeds and vegetation on the private premises.

§ 216-7 Recover of Costs: The owner of the premises on which a nuisance has been abated by the City shall be personally liable for the cost to the City of the abatement, including administrative costs. § 216.7.B. states all unpaid charges will be assessed to the property.

The costs associated with this are billed on a time spent basis. The current fee schedule includes a Mow Charge with Operator \$90.00 per hour and Weed Whip Charge with Operator \$75.00 per Hour. In addition to this charge is a \$25.00 non-compliance fee.

Bike, Skate & Blade Ordinance

City Code §99 regulates the use of bicycles, skateboards, rollerblades and similar items in the city of Isanti. It is unlawful for any person to ride a bicycle, or use a skateboard or roller blades upon a sidewalk within the downtown commercial district along Main Street between 2nd Avenue and the railroad tracks from 9 a.m. to 6 p.m.

Burning Ordinance

City Code § 119 permits burning by reference of MN State Statute 88 and the MN Uniform Fire Code. Campfires are permitted if applied as follows: A campfire is a fire set for cooking, warming, or ceremonial purposes, which is not more than three feet in diameter by three feet high and the ground surrounding the fire has been cleared of all combustible material twenty-five feet from the base of the fire.

Flushing of Water Mains April 27-May 8

If you live in or near an area that is being flushed, your water may have some discoloration for a short period of time. You should avoid doing laundry at this time or running your water, as this can actually bring discolored water directly into your home's pipes. Run your tap after the flushing and it should clear up. 
