The summer and fall of 2012 will be quite active for Isanti. We have a full summer of events with Redbirds baseball, soccer tournaments, BMX racing, Jubilee/Rodeo Days and the new Vision Wake Park. On June 20th we will celebrate our employers at the Mayor's Employer Appreciation Luncheon; which highlights our hard working businesses and all they contribute to Isanti.

Isanti has been proactively working through nuisance issues; such as the parking of cars, boats and trailers on grass as well as piles of debris and outdoor storage; and long grass and weeds. For those residents receiving violation letters; it has resulted in a few complaints. We have also received complaints from residents and businesses; wanting to ensure that Isanti is an attractive City in which to live and conduct business. We hear from real-estate agents and brokers trying to sell residential and commercial property in our City that nuisance issues are making it even harder in these tough times to sell property. This is a tough problem considering everyone has their own standard of what should be and should not be allowed. We all want to be "King or Queen of our Castle" and protect our property rights. The problem occurs when one person's property rights lock horns with the next person's property rights. Living in close proximity to so many others in a city necessitates the need for more rules governing behavior. This is never fun for those being regulated or for the Council that bears the final responsibility for passing City ordinances. However, the Council is working to protect the entire City and our property values.

These ordinances do at times change. For instance, after I became Mayor, I requested that work vehicles be allowed in residential areas. The previous rule did not allow for any work trucks or vans, such as a telephone or power company vehicle, to be parked in the driveway of a residence. My Yukon is not much different in size than a construction workers truck or power company van or many other vehicles that our residents use every day to make a living. So we went through the process and changed the ordinance, so it made sense. I hope to hear from anyone that has suggestions on how to make our community a better place to live, work, and play.

I wanted to share some highlights from our latest's Audit Report.

- City Administrative costs are 23% lower in Isanti than our peer group of cities
- City net debt is down 57% since I became Mayor
- Economic Development spending is 400% higher than our peer group of cities
- General Fund Balance is up from 58% to 89% due to cost cutting
- Park and Recreation spending is 42% less than our peer group of cities
- Liquor Store gross profit is up over 10% since our reorganization

We have put Isanti on firm financial footing as we face several more tough years. I am very optimistic about the economic development projects we have been working on. We have assembled an excellent team to manage our City into a brighter future.

### Additional Sign Reminders

- The City would like to remind local businesses that handwritten signs, whether temporary or permanent, are prohibited. All signs must be professionally made.
- Signs shall not be placed upon any public utility pole.
- Signs are not permitted within the public right-of-way.
- Temporary off-premises signs are permitted within the "B-1", "B-2", "B-3", "CBT", "RC", and "I" zoning districts, providing written permission is granted by the property owner and a temporary sign permit has been approved by the City. Temporary signs are allowed by an annual renewable permit.

### Recreational Vehicle Parking Ordinance

Chapter 227, Article II of the Isanti City Code; establishes regulations for the parking and storage of all types of vehicles within residential areas of the City. Seasonal time frames have been established for those units, to include boat trailer and/or boat, camping trailer, enclosed trailer, flatbed trailer, and all other RV's (except snowmobiles and ATVs) will be permitted from April 1st to November 30th. Fish houses on wheels will be permitted from November 15th to April 1st. Snowmobiles will be permitted from December 1st to April 1st. ATVs will be permitted from June 1st to November 30th.

#### **Economy Improving In Isanti**

The City of Isanti has recently seen an increase in commercial-industrial activity. Currently, the City of Isanti has 141 documented businesses that employ approximately 1434 people. These numbers show an increase of 9 businesses and an increase of 62 employees from this time last year. Purchases of existing buildings and expansions of others are the theme for early 2012. 605 1st Avenue NW was purchased by Conveyor's Direct (formerly from the City of Ramsey) and will operate a custom manufacturing business. 425 East Dual Blvd NE was purchased by Marla Properties and it will utilize the building for storage. Pat's Small Engine and Repair, celebrating its 5 year anniversary in Isanti, is in the process of adding 2800 square feet to accommodate its growth. Many other building purchases, expansions, acquisitions and new construction projects are in process or in concept stages. City staff is working hard to secure additional industrial, retail and commercial projects to provide employment opportunities as well as retail and dining options for Isanti residents.

The City of Isanti is the home of 141 businesses. These businesses employ 1434 people within our community. The five largest employers in Isanti are: United Parcel Service, Rum River Ornamental, McDonald's, Advanced Telemetry Systems, and Cambridge-Isanti School District 911. Our vibrant business community provides quality jobs, a substantial tax base and is actively involved in the community.

#### **Vision Wake Park**

Vision Wake Park opened in May 2012 in Bluebird Park. This unique water sport venue has been highlighted numerous times on Fox News 9. The artificial lake has a cable towing system installed that allows one to be pulled in a contained environment free from boat traffic and associated wakes. This is the only facility in the Midwest and it serves as a wonderful draw to the City of Isanti. #### **Historic Downtown Sign Constructed**

Construction was completed on a Historic Downtown directional sign located on the northwest corner of 1st Avenue NW and County Road 5 NW. This project was a public private partnership coordinated by the City of Isanti EDA and was made possible by contributions from area businesses and the City of Isanti EDA. Special thanks go out to KJD Signs and Jill Reller for collaborating on the construction and design of this project that should help improve commerce for the City of Isanti.

#### **Business Visits - Discovering Isanti**

Mayor Wimmer and Economic Development Director Sullivan make periodic visits to businesses in Isanti. The visits are informal and serve as an opportunity to learn more about what our businesses make, what services they provide, what their needs are, and how to identify what the City can do better to help them be more successful. Since January of 2011, 21 visits were conducted and a lot of positive and constructive feedback was received from businesses. The vast majority of the businesses that were visited expressed optimism for the upcoming year and were happy to call Isanti home. In a meeting with Auto City Classic, Staff was amazed to find out that this business is a company recognized worldwide for its ability to serve the classic car restoration part market. Although they specialize in classic windshields and custom glass this company is often able to find, or fabricate rare parts for the classic car you are looking to restore. A warm hello from your local Building Department! The City of Isanti is showing positive economic signs in both its' commercial and residential sectors. Very soon bells should be resonating from the new bell tower which is part of the new addition onto St. Elizabeth Ann Seton Catholic Church. Additions are also in the works for Pat's Small Engine and Repair and another industrial building on 1st Avenue NW. The rodeo grounds are building some preferred seating, to be added just in time for this year's rodeo during Jubilee Days.

In 2005, when the housing market slowed significantly, the construction of 16 town homes in various stages of completion came to a halt. In 2011, eight of those homes were purchased, construction was completed, and they are now all occupied. The remaining eight were sold this spring to another company and they are slated to be completed this summer which further reduces the vacant housing stock in Isanti. The City has issued its' first "new single family home" building permit for 2012 and another set of plans are currently being reviewed for a second home.

Summertime tends to be very busy with lots of projects. The following were just a few reminders relating to water that just may keep you out of hot water.

- The rising summer temperatures bring with them an increased interest in residential swimming pools. If the pool you are installing has a water capacity of 5,000 gallons or more, AND a depth capacity over 24 inches, it is required to have a permit and a self-closing, self-latching, non-climbable enclosure. Contact the Building Department for details.
- Sand point wells are required to be registered with the Minnesota Department of Health and the City of Isanti. Applications and additional information are available at the City Hall.
- Minnesota Plumbing Code requires domestic water supplies to be protected from lawn irrigation systems by a registered backflow device designed and approved specifically for that purpose. Thus, a permit and inspection is required when installing a lawn irrigation system.

# Restrictive Watering Ban in Force

City Code §325-2. Annual sprinkling restrictions. During the period from May 1 through September 1 annually, all property with addresses that end with an odd number may be sprinkled on odd-numbered days, and property with addresses that end with an even number may be sprinkled on even-numbered days. During this time period, no sprinkling shall be allowed from 12:00 p.m. to 6:00 p.m. each day.

This provision shall automatically apply unless superseded by action of the City Administrator. If the City Administrator determines that a water shortage exists, the City Administrator is authorized under City Code §325-1 to restrict the sprinkling of lawns by posting a notice at City Hall setting forth the restrictions.

A new property owner may request an exemption of the restrictions for the sprinkling of new sod. To request an exemption please contact Rick Sames, Building Official

# Are you cleaning up after your pet?

It is your responsibility as a pet owner to clean up after your pet. When taking your pet for a walk, please show courtesy to other public and private owners by removing the excrement deposited by your pet. City Code 87-5.1 requires pet owners to immediately collect and remove dog feces deposited by their animal on public or private property. A container, equipment, or other device is required for transport of the fecal material to an appropriate disposal receptacle located on the property of the pet owner. Please help us in keeping our neighborhoods and public spaces clean and sanitary.

### **Garage Sale Regulations**

With Spring and Summer, comes warm weather and garage sale events. This year, City staff has received many inquiries regarding the regulations for garage sales. Garage Sales are permitted within each of the residential zoning districts; however, there are rules that have been established with regards to the duration, signage, and number of events; which include the following:

- The number of sales permitted per individual property is not to exceed four (4) per year.
- The duration of a garage sale is not to exceed three (3) consecutive days.
- Any related signage shall be limited to the premises and to other residential property provided that the property owner's permission has been obtained to display such signage, and signage shall conform to the sign ordinance and shall be removed at the termination of the sale.

### School For All Seasons

The School For All Seasons is an option for Cambridge-Isanti Public School students in grades K-5. The program is located in Isanti, Minnesota at the Isanti Intermediate School site and is free to all students because it is a public school. School For All Seasons follows a year-round calendar that begins in August and ends in the middle of June. Students are given breaks between each grading period and summer vacation lasts about six weeks.

Multi-age homerooms that span grades K-5 and flexible grade level groupings for math, reading, social studies, science and language arts are a feature of School For All Seasons. School For All Seasons also offers community building activities twice a month that incorporate character education and citizenship.

The School For All Seasons is one of five elementary school programs in the State of Minnesota that follow an alternative calendar in this format. We feel that providing parents and students with different options is the best way to meet the needs of every learner. We also have a middle level program at Isanti Middle School called Minnesota Center for students in middle school (grades 6-8) that follows an alternative calendar. ### **Sign Regulations**

As a reminder to current business owners and any other individual looking to construct or place a sign upon their property or upon property owned by another individual, the City of Isanti has adopted regulations for signs. The ordinance regulates the location, size, and various features of signs to enable the public to locate goods, services, and facilities without difficulty or confusion; to prevent the wasteful use of resources in competition among businesses for attention; to prevent hazards to life and property; and to ensure an aesthetic value of the City.

Property owners looking to construct signs are required to obtain a sign permit from the City prior to construction and/or location of a sign. All sign applications are reviewed by City Staff to ensure compliance with the sign ordinance regulations. Signs constructed without a permit or signs found to be in violation of ordinance requirements and standards may result in a revocation of the sign permit for that particular business and/or issuance of a citation due to non-compliance with City Ordinances. ### **Engineering Project Updates**

**Legacy Park Trail** 

The City of Isanti is proposing to construct a nature trail through Legacy Park. The majority of the trail system is proposed to be surfaced with crushed limestone with some side trails having a simple dirt surface. The proposed trail will pass through a natural wooded area owned by the City of Isanti located to the northwest of the Villages on the Rum subdivisions. A culvert crossing will be constructed across Isanti Brook to provide access to the trail. This trail will give residents in the community an opportunity to access an undeveloped natural area. It provides an educational opportunity showcasing undisturbed forest as well as the Isanti Brook and Rum River basins, which contain many types of flora and fauna. The trail is designed to be handicap accessible to provide access for everyone and allows a natural setting for running and walking as well.

Construction is planned to commence in June and be completed and open to the public by the end of August. Please call City Engineer Brad DeWolf P.E. at 612-756-1032 if you have any questions.

### Weed and Grass Nuisances

Summer is approaching and with that comes the season of lawn care. The City of Isanti would like to bring to your attention City Code – Chapter § 216 and the fines associated with violation of these provisions.

Public nuisances affecting health: All noxious weeds and other rank growths of vegetation upon public or private property. In accordance with the notification requirements of §216-6 of this chapter, and after seven (7) calendar days notice by the City, the Public Works Director shall implement the mowing and removal of noxious weeds and vegetation on the private premises. The owner of the premises on which a nuisance has been abated by the City shall be personally liable for the cost to the City of the abatement, including administrative costs. All unpaid charges will be assessed to the property.


The costs associated with this are billed on a time spent basis. A \$25.00 non-compliance fee is charged in addition to the cost.

The graph provided shows the reported number of crimes for the past few years (2007-2011). Reported crimes are crimes that community residents and businesses report. Traffic offenses are both officer initiated and community reported. Over the years, the reported crimes have remained level. The biggest change seen is the decrease in thefts. On the traffic side, the Isanti Police Department has worked very hard to lower the number of drunk drivers in the community. Our budget has remained the same or decreased over the years, and hopefully, our crime rate will do the same.

### **Burning Permits**

City Code prohibits burning by referencing MN State Statutes 88.1 and 88.22 and the MN Uniform Fire Code. Campfires are permitted, if the following provisions are met. A campfire is a fire set for pleasure, cooking, warming, ceremonial purposes or similar purposes, which is not more than three feet in diameter by two feet high. Recreational fires must be at least 25 feet from all buildings or combustible materials. Combustible materials are things such as wood, paper and plastics.

Any fire larger than the above stated dimensions is considered "open burning" and is regulated by the DNR. Burning grass, leaves, brush and lumber requires a permit. Permits can be obtained from the Isanti Fire Department 763-444-8019 or application can be made on their website at www.isantifiredistrict.org.

### Wise Ways to Use Water

- Keep a pitcher of water in the refrigerator rather than running the tap until the water gets cold.
- Take shorter showers. A quick shower rather than a bath can save an average of 20 gallons of water. The Environmental Protection Agency recommends taking three- to five-minute showers.
- Garbage disposals use approximately 11.5 gallons of water per day. Try composting organic wastes instead.
- Use the dishwasher and washer only when you have full loads.
  - Use mulch around trees to slow evaporation.
- Direct downspouts and other runoff toward shrubs, trees and gardens.
- Water lawns and plants early in the morning or during the evening when there is less evaporation.




