### J. Business Items City Administrator Don Lorsung

**1.** City Administrator Transition

a. Resolution 2019-020 Approving Contract for City Administrator Position A motion was made by Collison, seconded by Lundeen to approve City Administrator contract. Councilmember Lorinser questioned if contracts were able to be discussed in an open session. City employees Josi Wood and Don Lorsung questioned if they were opposed to their contracts being discussed in an open session meeting. Don Lorsung and Josi Wood both agreed to allow their employee contracts to be discussed in an open session. Council Member Lorinser addressed concerns to Josi Wood's City Administrator contract including salary, vacation time and if the cost of the car allowance should be included in Mrs. Wood's annual salary. Josi Wood shared that other than her family, the needs of the City will be her priority. Council Member Bergley asked if there was an advantage for the City or for Josi Wood with having the car allowance. Council Member Lorinser stated that the advantage to the City when Don Lorsung was City Administrator was that it lowered Don's annual salary and gave him extra money where there would not be a pay equity issue. Council Member Collison questioned if the money is pre-taxed. Don Lorsung responded informing Council that the money is pre-taxed. Council Member Collison shared that other cities either offer a company car or a car allowance. Subsequently, to discussion a motion was made by Lundeen, seconded by Lorinser to approve City Administrator Contract with the modification to add \$4,200.00 car allowance into Mrs. Wood's annual salary. Motion carried.

b. Resolution 2019-0231 Approving Contract for Assistant City Administrator/ Special Projects Position

Don Lorsung shared that he considers this position to be a great opportunity for him to continue to serve the City. Mr. Lorsung continued to share that he will be updating Comprehensive Plans, review and update City codes, assist in orientation of new Community Development Director, and assist City Administrator as needed. Councilmember Lorinser addressed concerns to Don Lorsung's Assistant City Administrator/ Special Projects contract including severance package if the City were to terminate Mr. Lorsung the City is responsible to pay Mr. Lorsung a 6 months' severance package and varying the contract's end term June 2020. Subsequently, to discussion of Don Lorsung's Assistant City Administrator/ Special Projects contract, a motion was made by Collison, second by Bergley to approve contract with the modification of the contract term ending June 31, 2020. Motion passed 4-1 with Lorinser voting nay.

2. Appointments to Committees and Boards- Tabled Appointments

Mayor Johnson shared that the second alternate appointee for Fire Board and ICICLE were tabled at the last City Council Meeting. Councilmember Bergley expressed that he would like to be removed as the alternate for Fire District and that he would like to appoint Mayor Johnson as the alternate. Mayor Johnson questioned if City Administrator and Councilor Bergley should both attend ICICLE Meetings. Don Lorsung suggested Bergley and Wood attend and they can report back if they shall both continue to attend. Councilmember Lorinser questioned why he was not included and Mayor Johnson stated that the committee appointees remained the same as 2018 with the exception of Fire Board and ICICLE. Councilmember Lorinser requested to be on the Bike Isanti Committee as well as the C-I Bike/Walk Trail Committee. City Attorney Clark Joslin informed City Council that if a meeting is open then it is fine for Councilor Lorinser and Mayor Johnson to both attend the meetings. Clark Joslin continued to share that C-I Bike/Trail and Bike Isanti both meet the open meeting requirements allowing both to attend.

Motion by Lundeen, second by Bergley to approve. Motion carried.
