E. Proclamations/Commendations/Certificate Awards

1. City of Isanti - Recipient of MDH 2016 Water Fluoridation Quality Award The Minnesota Department of Health announced that the City of Isanti has been awarded a Water Fluoridation Quality Award from the U.S. Centers for Disease Control and Prevention. There were 1,396 cities in 29 states that received the award for 2016, and in Minnesota there were only 104 of the possible 603 entities receiving it, with the City of Isanti being one of them. Nationally, nearly three quarters of the population is served by public water systems. The Public Works Department is to be commended.

2. Presentation of Green Steps City Signage

Public Works Director, Josi Wood, has taken the lead with the Green Steps Program and been instrumental in getting the City of Isanti to Step 4, which is a big milestone. The Green Steps Program, which is sponsored by and run through the Minnesota Pollution Control Department, gets the City to look at the environmental impact of all decisions and things that can be done for better environmental practices. The City of Isanti is the only Green Step City in the area.

K. Business Items

1. Interview Applicant for the Vacant Term Seat for Park, Recreation & Culture Board Jenny Garvey, 1000 Isanti Parkway, was the only applicant for the open Park, Recreation, & Culture Board seat. Ms. Garvey was asked questions specific to the Board.

- **3.** Consider Designating an Official Newspaper and Appointing Depositories and Professional Services for Year 2018
 - **a.** Open Bids for the Designation of the City's Official Newspaper City Administrator Lorsung informed the Council that the City received two bids. One was from ECM Isanti County News and the other from Isanti-Chisago County Star. He then proceeded to open those bids.

Mayor Wimmer said that the Isanti County News is more expensive, but it reaches all the residents and covers the community more.

City Attorney Clark Joslin

- **8.** Review Conflict of Interest Policy
 - a. Resolution 2018-008 Approving the City of Isanti Conflict of Interest Policy City Attorney Clark Joslin addressed the Council regarding the annual review of the City of Isanti's Conflict of Interest Policy. Mr. Joslin explained the Conflict of Interest policy was adopted by the City several years ago and is readopted each year. There are no significant changes in the law, nor have there been changes in the terms of the policy from prior years. The purpose of the policy is to avoid the appearance of impropriety, conflicts of interest, or that the City Council's decisions are based on anything other than the Council's best judgements and actions for the betterment of the City and the benefit of the residents and taxpayers of the City. To that end, the policy provides that members are to avoid and decline to participate in any business transactions in which they, a spouse, or an immediate family member would have a direct financial interest. Mr. Joslin noted there is a state law at the end of the policy which provisos that it is a criminal offense to knowingly participate in any matter in which they have a direct financial interest. Mr. Joslin continued to review the policy and give examples of what would constitute a conflict. He also said that conflicts are not always financial or contractual in nature and may instead fall into a gray area between personal interest and benefit. Mr. Joslin provided examples of when this could occur. He said the bottom line was that decisions are to be made on objective criteria and not personal criteria, and concluded with the adage of "if in doubt, check it out". Councilmembers and Board members may contact him if they have any questions Mr. Joslin also shared that there is an updated memo in brochure form about this. regarding Conflicts of Interest on the League of Minnesota Cities website.

Mr. Joslin also touched briefly on the Open Meeting Law by saying the League of Minnesota Cities has a very detailed memo on this topic which was recently updated and can be accessed on their website. The main points are that: all meetings of the City Council and advisory boards are subject to the Open Meeting Law; notice for all meetings is required; no official business can be discussed or conducted outside of the official meetings in any form in order to provide transparency.
