## E. Proclamations/Commendations/Certificate Awards

Presentation of the Outstanding Conservationist Award (Tiffany Determan, Isanti Soil and Water Conservation District)

Isanti Soil and Water Conservation District Manager Tiffany Determan and Isanti Soil and Water Treasurer Al Koczur presented the City of Isanti with an award for the city's contribution with applying conservation practices and natural resources. Tiffany shared that Isanti Soil and Water Conservation District partners with Minnesota Soil and Water Conservation District where the partnership identifies one individual or organization for their accomplishments executing conservation practices and natural resources each year. Tiffany Determan continued to applaud the City of Isanti for being chosen unanimously as the recipient of the 2018 Outstanding Conservationist Award where the City will also be recognized at the Outstanding Conservationist Luncheon on December 11th, 2018 and the state annual convention. Tiffany shared that the affiliation between the City of Isanti and Isanti Soil and Water initiated with a Storm Water Retrofit study in 2011 that identified places to cost effectively improve storm water portions of the city that discharge into the Rum River. The outcome of the study led to a \$120,000 clean water fund grant to install a pollution control project located on Railroad Ave. Tiffany further shared that the city provided a \$39,000 match through a storm water utility fee where the partnership has led to sequential joint conservation projects such as erosion control on the Rum River at River Bluff Park and the City wide rain garden, and ground water conservation at the City Hall and the Community Center. Tiffany Determan personally recognized and commended Mayor Wimmer, Katie Everett and Josi Wood for their ongoing pursuit to conservation within the City of Isanti.

# **Community Development Director Ryan Kernosky**

1. Resolution 2018-234 Authorizing Submittal of 2018 Comprehensive Economic Development Strategy (CEDS) to East Central Regional Development Commission (ECRDC) Council Member Bergley questioned what was being voted on. Mayor Wimmer explained that it is for potential state and federal funding for Rail Served Industrial Park, Downtown Redevelopment, Mechanical Sewer Treatment Plant Upgrade and Implementation of Economic Development District No. 1.

Motion by Lorinser, second by Collison to approve Resolution as presented. Motion carried.

2. Resolution 2018-235 Approval of Final Plat for Legacy Pines

Economic Development Director Ryan Kernosky explained that this is the final plat for Legacy Pines. Ryan Kernosky shared that Legacy Pines is a development on the North East corner of the city and is along the extension of Bellaire Blvd and Moline Loop where it abuts Legacy Park. Ryan Kernosky further shared that the developer has addressed the concerns that city staff and Planning Commission have brought forward.

Motion to approve with staff recommendations by Lorinser, second by Bergley. Motion carried.

3. Resolution 2018-236 Accepting the Temporary Easement Limited Warranty Deed for Legacy Pines Subdivision

Economic Development Director Ryan Kernosky addresses that the current access easement runs along the proposed future right of way on Bellaire Blvd. Ryan Kernosky shared that this resolution is to accept a new temporary easement that would allow residents to accessibility to Legacy Park as well as a proposed extension of sewer and water utility easement and a temporary turn around at the termination of Bellaire Blvd. Ryan Kernosky concluded by sharing that these are temporary easements that will retire once the project is constructed in later phases.

Motion by Lorinser, second by Collison to approve Resolution as presented. Motion carried.
