# J. Business Items

# 1. Discussion on School Resource Officer

Mayor Wimmer shared that the City has not received any response from the letter sent to the school district regarding the part-time school resource officer being made full-time. The school district runs on a different Budget calendar with the school district's calendar running through June 30<sup>th</sup>. The City contract with the school district for the part-time school resource officer terminates at the end of June. Another communication will be sent asking if they will continue the SRO position on a part-time basis. The issue is highlighted by the fact that the school resource officer, Adam Gau, has received both the 2017 School Resource Officer of the Year from the Minnesota Juvenile Officers Association and the 2018 Distinguished Service Award from the Minnesota Chiefs of Police Association this year. It is unclear why the district is not communicating about this issue when discussions have occurred between the school district and the City regarding other issues, such as the tennis courts. Mayor Wimmer mentioned that he is aware the district has cut about 1.5 million out of their budget and speculated that this may be part of it. However, the City has to plan accordingly and look at the budget so adjustments can be made if necessary.
