The only way the City would be able to control the properties in the townships, which the City surrounds and borders in some areas, would be to forcibly annex the townships.

Parson asked for a map of the City with all City and townships lines to see where the City code in enforced.

Mayor Wimmer informed Parson that this map could be found on the City website.
