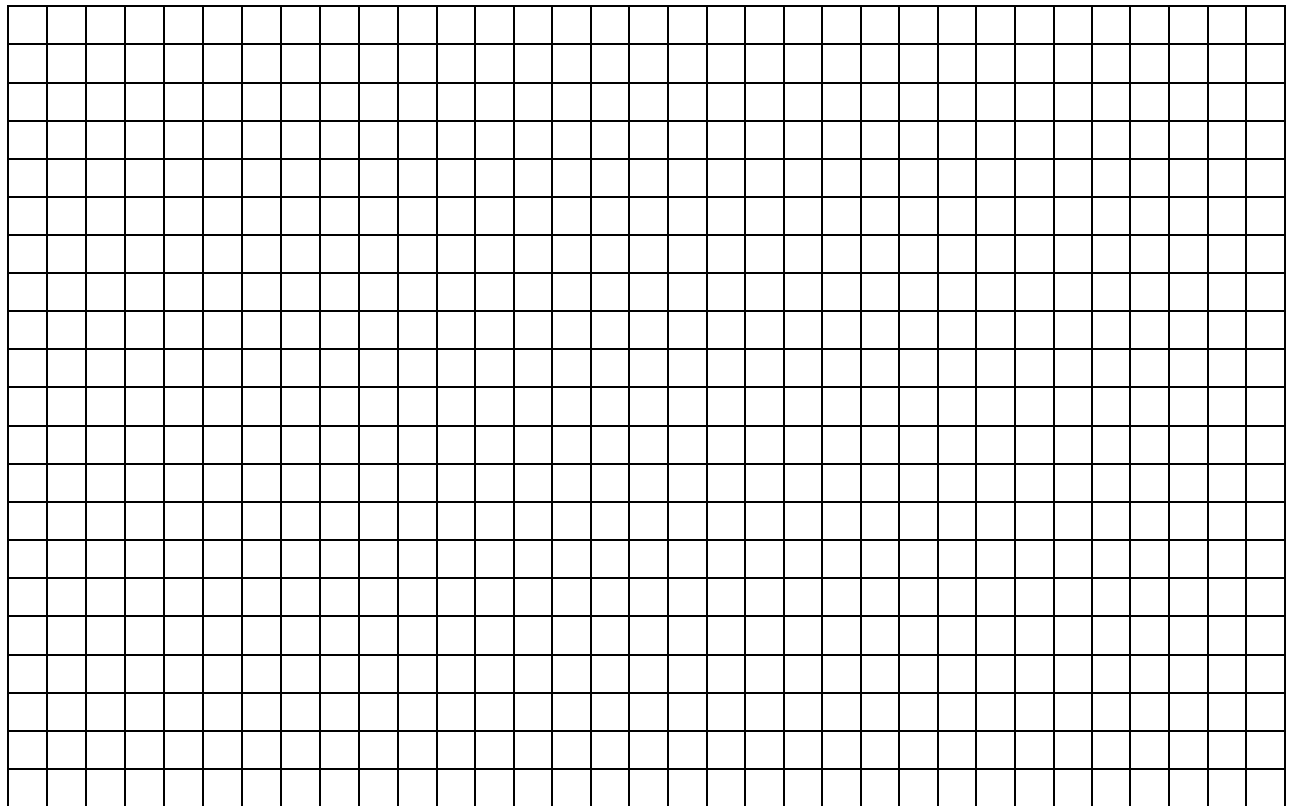

A dog(s) must be on a leash of not more than six (6) feet in length, or confined to the owner's property by adequate enclosure or fencing.
